

# EXHIBIT "A"

ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS, that Preferred Medical Plan, Inc., a Florida corporation ("Assignor"), for good and valuable consideration, has irrevocably assigned, transferred, conveyed, and delivered to MSP Recovery, LLC, its successors and/or assigns, including but not limited to any related entity now or hereafter created, collectively referred to as Assignee, any and all of Assignor's right, title, ownership and interest in and to the following property, including all lien and recovery rights thereto:


-Accounts receivable in the form of (i) premiums owed by past enrollees in health plans issued or administered by Assignor; (ii) overpayments by Assignor to physicians and other providers for services in connection with health plans issued or administered by Assignor; (iii) overpayments by Assignor to marketing agencies used in connection with health plans issued or administered by Assignor; (iv) outstanding liens, potential liens, lien rights and subrogation recovery rights in favor of Assignor against recoveries by enrollees, including in any litigation commenced by enrollees;

-All legal rights to the accounts receivable and lien reimbursement and recovery rights in connection with the foregoing along with all ownership and recovery rights in connection with costs and/or claims related to health care services paid by or on behalf of Assignor related to Assignor's Medicare Advantage Health Plans or Medicaid business and for which Assignor has or had legal recovery rights pursuant to contractual, statutory or equitable legal theories, whether state or federal (including the Medicare Secondary Payer Act) and whether arising as Part A, B or D claims, including any rights against primary payers.

The transfer, grant, right, and assignment of Assignor's right, title, ownership, interest and entitlements in and to the foregoing shall be the exclusive property of Assignee and this Assignment is irrevocable and absolute and shall be binding upon the successors, legal representatives or permitted assigns of the parties hereto. Assignee is authorized to collect and negotiate the foregoing liens and receivables and enter into applicable releases.
